Pursuant to the recommendations of the Departmental Promotion Committee (DPC), constituted vide Government Order No.115-GAD of 2019 dated: 23.01.2019 in furtherance of SAC Decision No.166/22/2018 dated: 07.12.2018, held on 22.04.2021 and in continuation of Government Order No: 98-Edu of 2022, Dated: 07.03.2022, sanction is hereby accorded to the regularization/promotion of I/c Lecturers and Masters as Lecturers in the School Education Department in the pay grade applicable at relevant point of time, now revised to Pay Level 9 (52700-166700), as per the details shown against each in the lists forming **Annexure** to this Government order.

It is further ordered that:

1. The above promotions shall be without prejudice to the outcome of the writ petition(s), if any, pending consideration before the competent court(s);
2. The notional effect to the promotions, wherever indicated, shall not entitle the officers to the grant of any monetary benefit/drawal of arrears and shall be for purposes of seniority only; and
3. The seniority of these officers shall be notified as per rules, separately; and
4. The genuineness of PG degree certificates/Institutions from where the degree has been acquired shall be ascertained by the concerned Directorates, keeping also in view the UGC guidelines issued from time to time regarding validity of the degrees and that the degree has been acquired after availing leave and proper permission from the competent authority.
5. That the concerned Drawing & Disbursing Officer(s)[DDOs] shall obtain an undertaking in the shape of an affidavit, duly attested by the 1<sup>st</sup> Class Magistrate, that if the service particulars/PG degree certificate is found fake/forged/tempered or issued by Un-recognized University or if the course is proved to have been Un-recognized at a later stage, he shall have no claim, whatsoever, and the promotion shall be deemed to be treated as cancelled *ab-initio*, without further notice. The DDOs shall be personally responsible for implementation of the conditions *ibid*.
